## From The Village President

The Pool House and Recreation Center was given final approval by a unanimous vote of the Master Association Presidents at the June 2, 2016, meeting. This vote was on a motion by Bob Bronner, chairman of the Master Association Finance Committee as follows:

To authorize the managing agent in cooperation with Tom Daley of Daley & Jalboot Architects to finalize an agreement with QBD Construction, Inc., to accomplish the renovation and reconstruction of the pool house into the planned recreation center for a total cost not to exceed \$781,258 - an amount which includes a 5% contingency or \$35,000 which will allow for some change orders before having to return to the full MA for additional authorization, and \$20,000 for furniture and equipment.

This project will be funded as follows.

The first \$250,000 from the accumulated CIF funds on hand.

The next \$80,000 from the MA Reserve fund of monies accrued for pool house repairs.

The balance of \$451,258 from the Vision Quest Fund.

The existing Comcast agreement expires in May 2018. A telecommunications committee has been formed to develop an approach to take on sending out requests for information to several providers to gain insight into their interest and capabilities in possibly serving HM cable/internet needs in the future.

The progress on the walking trail between the East Gate and the Inverness entrance is slowly moving ahead. The goal is now for completion late summer or early fall.

A request by the pool committee for an AED (Automatic External Defibrillator) at the pool area for use in the recreation area complex was approved by the board of directors. Also approved was one AED for the Community Center.

**Inverness Village Meeting - May 11, 2016**

The following unofficial summary of the meeting is presented for the benefit of those unable to attend in person.

The meeting was opened at 7:30 PM by President **Boyd Mackleer**, with council members **Wilbur Amand**, **Tom Delaney**, **Janet Emanuel** and managing agent **Jeff Bevan** in attendance. The fifth council member, **Barbara Atmore**, was absent. Boyd started by recognizing new residents, **Louise and Dave DeNight**, and **Pat and Jim Aubry**. Following that, the minutes of the previous meeting were approved, and the Treasurer's report was given by Tom Delaney. Tom noted that fortunately we will not need an additional assessment for snow removal this year. He said the village has a substantial reserve fund, but will need expenditures to deal with wood replacement.

In his president's report, Boyd outlined the status of the Pool House refurbishment, which is scheduled to begin this fall and should be completed by next spring. He also described improvements at Sullivan House. Boyd then went on to describe the upcoming Inverness village needs for updating of home alarm systems, and roof replacements. Boyd stated that roof work will be scheduled as needed. In response to a question, Boyd discussed the involvement with the town over the construction of the walking

trail to the East Gate, where there are several issues to be addressed. He also noted that the Master Association is looking ahead to contract negotiations with Comcast and others about the cable TV service, which is coming up in 2018.

Under committee reports, **Jack Gaskill**, architectural committee chair, noted that the committee and the council must approve all plans for work involving the exterior of a unit, including window replacement. **Maryjane Hahn** reported for the landscape committee, and noted that the annual walk-through to plan further work will take place in May. **Barbara Colby**, reporting as the village greeter, noted that **Ann and Bob Latoff** and **Rosemary and David Bozeman** have also recently moved into Inverness. Newsletter editor, **George Colby**, recognized the valuable support of editors **Carol and Jim Ellis**, and the addition to the publishing staff of **Mary Lou Perry** and **Terry Marran**. He also thanked the continuing contributors. Social committee chair, **Carol Ellis**, described the Ice Cream Social, scheduled for June 15th. She also noted the need for additional volunteers to work on this and other village social events.

For council member reports, **Janet Emanuel** said that the council is working on an update of the village rules and regulations. She noted upcoming events, such as the production by the Hershey's Mill Players, and the East Goshen Community day in August. She also discussed work needed on the Hershey's Mill dam and another dam in East Goshen township. Both efforts will cost the town a considerable amount of money.

The results of tonight's election were certified. As there were no contests, the same members remain on the council. This was followed by a discussion of dryer vent cleaning and further questions on the alarm systems. It was noted that updating of the alarm system will require the installation of additional sensors to cover all bedrooms and each level of the unit. Dryer vents are cleaned from the outside by a village contractor every few years. We will be advised when the next cleaning will take place.

## Decision Making in The Mill - As I See It

Hershey's Mill is administratively subdivided into 25 separate villages, plus a Master Association which directs and oversees all things common to all residents. Common amenities include the swimming pool, tennis courts and other sporting venues, the Sullivan House, the Community Center, the wood shop, cable TV, Security, and the waste treatment plant. The Golf Club is owned by Robert Wooldridge, the developer of much of Hershey's Mill. Residents are free to join the Club, either as golfing members or house (dining) members, for an annual fee.

The Master Association collects a fee from each household to finance its operations. This fee is incorporated into the village condo fee.

### **Village Affairs:**

The legislative concept of the community is that each resident is a voting member of the Homeowners Association (HOA) for its village. Villages are managed by a village council. Residents vote for members of their village council, and then the council members elect a village HOA president. That position is especially important, because the village president becomes a member of the Master Association.

The Inverness Village Council consists of the five members listed on Page 13. For administrative support, the village employs Jeff Bevan of Hershey's Mill Management as Managing Agent. The village council sets the rules and regulations for the village, and directs all maintenance activities. The village HOA is responsible for maintenance of the village common areas and the exterior of each dwelling.

Each village sets its own budget, which is voted on at a village meeting, usually held in November. This sets the village condo fee, which is paid quarterly. Election of officers for the village council occurs at a late spring village meeting.

### **The Master Association (MA)**

The Master Association is comprised of the Presidents of each village HOA. Five elected officers make up the Board of Directors (BOD) of the Master Association. The Board of Directors does the proposing and planning of actions by the Master Association as a whole. Proposals are then voted on by the entire MA.

Residents interact with the Master Association through their own village president. One wishing to propose actions by the MA should talk with their president to persuade him/her to forward the proposal to the Board of Directors for consideration.

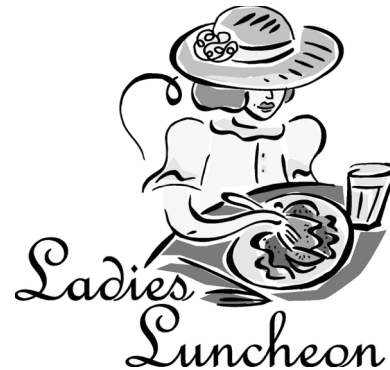
## GREAT NEWS !!!!

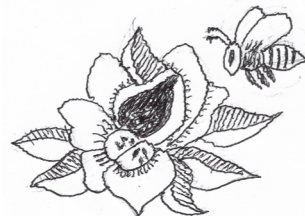
Bill and Helene have a son, who now lives in North Carolina, with their daughter; two other children live in Watertown, NY. They have four great-grandchildren.

## Legal Column - Planning for Future Care

At one time, future planning involved only wills, trusts and powers of attorney. The emphasis of the plan was on the end of life and generally called Estate Planning. Most people had wills and powers of attorney, and many may have had trusts either created during their lifetime or created under their will at the time of death. There was an emphasis on death tax avoidance and providing for beneficiaries' future care, as well as on preserving assets and passing them on. However, in the last 30 years, the aging demographic trends have added increased focus on health care and long-term services and support of older persons.

In some Pennsylvania counties the senior population is already 20 percent and projected to grow as the "Baby Boomers" move into the senior group. Seniors could be coping with the most significant physical, emotional and financial times of their lives, and they might suffer from cognitive losses that inhibit the ability to understand and communicate. Due to the complexity and fragmentation of this country's long-term care financing and delivery systems, seniors often have great difficulty obtaining information, accessing services and qualifying for financial assistance. Therefore, it is important that seniors, before moving to health care facilities or making other long-term care provisions, have in place (1) a power of attorney for financial affairs; (2) a power of attorney for health care decisions; (3) an advanced medical directive (living will) setting forth the senior's personal wishes; and (4) a will or trust agreement to dispose of assets at death not covered by specific beneficiary agreements.

In addition, the facilities available for care and the methods of supplying care have expanded greatly. The classifications of types of care, definition of care, limits of coverage and endless alphabetical terms like SSI, CMS, SMI, etc. just stretch the ability to comprehend by a lay person. Which type of care is best for the senior?

How do people pay for long-term health care? There are many ways:

First, of course, is the old fashioned method of cash accumulated over the years.

Second: Retirement benefits.

Third: Long-term health care insurance (LTCI).

Fourth: Social Security benefits.

Fifth: Medicare plans and Medicare Supplemental coverage.

Sixth: Veterans Benefits.

Seventh: Medicaid (Medical Assistance).

Eighth: Reverse mortgages.

These are only some questions which should be reviewed with a qualified advisor. It is not a good idea to ask your neighbor or friend what he or she has done. The rules of Medicare and Medicaid are extremely complex and understanding them is no easy feat. They are dense reading of the most torturous kind, and Congress revisits the area frequently making any solid grasp of the matter merely a passing phase. Long-term care provided outside of facilities is commonly referred to as home and community based services. These services refer to another whole array of supportive services, such as homemaker and chore services, home health aides, therapeutic services, geriatric care managers, adult day programs, home modification transportation. When having paid home care workers, there are advantages to using an agency. All certified and licensed agencies must meet standards set by state or federal governments. Workers are screened for criminal records and are monitored by the agency. Workers are insured and the agency handles all paperwork.

Finally, the local office of senior affairs may supply counsel as to benefits and services available.

The conclusion seems to be that before moving to a care facility or care at home, seniors should consult more than one professional. Varied expertise is needed: lawyer, accountant, financial advisor, insurance broker, doctor and health care advocate are some that come to mind.

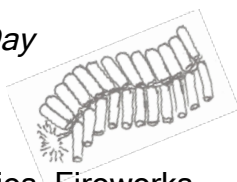
