Jefferson Residents Attend Meetings, Showing Care and Concern for Village Governance

Two autumn open meetings of Village HOA bring out standing-room-only crowds

The first of two recent open meetings of Jefferson Village HOA took place at the HM Community Center on October 8. The meeting was convened in response to a petition signed by a number of residents as required by Village bylaws. Petitioners expressed concern over Village Council’s management of the business affairs of the village, specifically with regard to the vinyl siding exterior re-cladding project approved by Council this past summer and the assessment to finance the project now.

The capacity crowd was greeted by Council President, Steven Friedrich who introduced the meeting’s presenters. Council Member Kim Morton explained the 8-year history of Council’s research into the various material and financial options of replacing our village’s 30-year-old cedar siding. Council Member Hal Deal then expressed the urgency of the project, explaining that repairs to existing siding were accelerating rapidly and the costs were becoming astronomical.

Mark McCann of Falcon Engineering then demonstrated that repairing, replacing and repainting our current wood siding would end up costing residents an additional \$1M more than a transition to vinyl siding over the next 30 years due to the much lower maintenance costs of vinyl. He corroborated the need for urgency as his recent inspection showed our current siding would not last much longer. Mr. McCann also explained the scope and procedure for the upcoming project.

Long-time Council Member and President, Don Fell, gave a detailed presentation on the budgeting and reserve fund process of the HOA and how it has successfully anticipated all routine maintenance costs over the past 2 decades. Our Managing Agent, Steve Erney, then compared the superiority of our budgeting process over other villages with his extensive experience in management of other HOAs.

Robert Hoffman, of the law firm Marcus & Hoffman, concluded the evening’s presentations with his careful review of Village bylaws, and demonstrating that Council’s decisions were not only in compliance, but were also made with due

diligence to Council’s responsibility to maintain the value, appearance, and pristine condition of communal properties. Had Council not made this difficult decision to proceed with the project, it would have then been negligent in its duty to village residents.

After an extensive question and answer session, residents appeared to be assured that all was in order and that the decision to go ahead with the re-cladding project was a reasonable one. While no one was thrilled that an assessment was necessary to fund the project, at least there was a general understanding by all in attendance that it was necessary.

The scheduled Open Meeting of the Village HOA took place on November 12. Once again the meeting drew a full house at the HM Community Center. However, this meeting was to review the budgeting for the Village for the fiscal year 2019. Don Fell gave a detailed explanation of the budgeting process over the past 20 years and how that experience was applied to the coming year’s budget. While most categories of the budget remained mostly unchanged from 2018, there were 3 areas that increased rather substantially. Two of those categories were out of Council’s control—the cost increase in our water supply and the fees charged by Hershey’s Mill Master Association. The third area of increase was in tree removal. Council Member, Becky Green, explained the need for removal of trees that would interfere with the upcoming vinyl project.

However, Council was able to lower the General Maintenance budget and keep other areas of the budget under control. The net effect was a \$26/month increase per household in HOA dues (see chart below). This figure will keep Jefferson Village in a comparable range to the dues of the 24 other villages in Hershey’s Mill.

Is Your Home Ready for Winter?

This unusually stormy year has played havoc with village landscaping plans. Removal of autumn leaves has been delayed as a result, but will surely take place in early December. The late November blizzard caught everyone by surprise, including PennDOT. Walkways and streets were cleared as quickly as plows could arrive. Hopefully, this coming winter will be kinder. In the meantime, please take note of these helpful hints to prepare your home for winter weather.

- Disconnect all hoses from outside faucets. Be sure to drain all water from them before placing them away for storage.
- Turn off water to outside faucets.
- If you are away from home for more than a few days, be sure to turn off your water at the inside main valve and to set your thermostat no lower than 55° (as your smoke detector won't function properly below that temperature).
- If you have a fireplace, call a chimney sweep to give the flue a thorough cleaning. Creosote builds up quickly with regular use of a fireplace and poses a safety risk if not cleaned. It is recommended that flues be cleaned after every 20 uses of your fireplace.
- If you use your fireplace often, make sure your smoke detector is functional and consider installing a carbon monoxide detector.
- Remember to change the air filter in your furnace.
- Make sure your dryer vent line is clean and has no breaks or separations. Excess lint can accumulate within walls, attics or crawl spaces. Lint has a very low flash point and is a serious fire hazard. Though the Village cleans the vents on your behalf once every 3 years, you may want to consider additional cleanings at your expense. Contact Jay Irwin @ Ups & Downs (610-842-1296) or any qualified contractor to discuss the condition of your dryer vents.
- Jefferson Village maintains a sufficient supply of special salt that is required for the quad ramps. Each quad has a container of this salt. Residents of each quad should make sure salt is spread on the ramps and porches each night to prevent ice accumulation overnight. Salt is available to all residents at the mailbox kiosks. All are encouraged to use village salt supplies on walkways as needed.
- Please remove flower pots, door mats, benches, etc. from your front stoop or porch when snow or ice is forecasted to prevent potential damage, and to enable the snow removal team to provide a thorough clean-up of all entrances.
- Most important, take extra precautions to maintain your safety over the winter months. Our goal is "0" injuries.

Paul Atterton—The Birdman of Jefferson


