I live in an upper quad and have found I needed to vacuum after the workers were done, and would suggest that others do the same. The workers are very careful and blow the debris away, but nothing gets the dirt out better from carpet than a good vacuuming, especially the ice-melt salt that gets tracked into an entrance. Folks often ask me regarding HM as to why don't we have a workout facility. I thought this as well when I first moved here, but quickly realized this would create a liability for every resident and put a burden financially on a lot of folks that are not interested in working out. (The Hershey's Mill Master Association occasionally considers this issue.) But did you know that the "Y" does not charge an initiation fee to HM residents? Also, it will suspend monthly membership fees if you are away and request it. In the meantime, we have wonderful walking trails right here in HM that just keep getting better. The path around the lagoon is exactly ½ mile, and there are 2 lovely nature trails adjacent to it. That is something worth mentioning if/ when the subject of exercise ever comes up.

# Things to Know if Planning to Move or to Be Away for an Extended Length of Time

Jefferson Village has a few regulations that are often overlooked by residents who are planning to move or who may be away from home for a lengthy time. Our residents living alone may also want to inform their executors of these rules in order to properly prepare an estate for settlement.

- Electric service to any residence may not be shut off for any reason so that heat and security systems remain functional. Thermostats must not be set lower than 60°F to prevent accidental tripping of security alarms.
- Water service should be shut off at the main valve.
- Hard-wired house telephone must remain in service at all times and is never to be discontinued for any reason so that the property remains secure. (There is no cost for this as telephone service is covered in HOA dues.)
- Verizon equipment that stays with the house: ONT box, transformer, battery back-up, and purchased wifi extender.
- Verizon equipment that gets returned to Verizon: HD Set-top Boxes, Digital Adapters, Router, DVRs, rented extender.
- You may only cancel Verizon services that are NOT included in the HM Bulk Plan. For more information contact Verizon Call Center 800-501-1172.

### East Goshen One of Safest Cities in USA

A ccording to a recent report in Alarm Grid, East Goshen is among the top 100 safest "cities" in America today, where your home is least likely to get burgled. Based on a list of burglaries per capita in cities with a population of at least 10,000 from the FBI crime data list of 2018, the Westtown-East Goshen placed 67th with 2.79 burglaries per 10,000 residents. Two other Chester County municipalities, Upper Uwchlan and Willistown, also made the list, making Chester County one of the most burgle-free regions in the USA.

### Did You Know...???

Less than forty years ago, the giant Canada goose was extremely rare. As a result of restoration efforts and a large increase in small urban and suburban water bodies, Canada geese are now quite common. Many people enjoy seeing them fly in a v-formation or hearing their distinctive honk, but problems can occur when too many gather in one area.

Typically, developers and landowners unknowingly cause the problem by creating ideal goose habitat. Geese feed extensively on fresh, short, green grass. With a permanent

body of water nearby (such as our lagoon, ponds, creeks and gardens) conditions are perfect for geese to concentrate, reside and multiply. Geese also have a strong tendency to return to the same area year after year. Once geese start nesting in a particular place, the stage is set for more geese in the future.

FEEDING GEESE MAKES THE PROBLEM WORSE. It concentrates larger numbers of geese in areas that under normal conditions would only support a few. Artificial feeding also disrupts normal migration patterns and holds geese in areas longer than usual. With too much food available, geese will devote more time to locating nesting sites and mating. Congregating geese can cause damage to the landscape. Large amounts of excrement can render swimming areas, parks, golf courses, lawns,



docks, and patios unfit for human use. Since they are active grazers, they are particularly attracted to lawns and ponds located near apartment complexes, houses, and golf courses. Geese can rapidly denude lawns, turning them into barren, dirt areas.

Geese are particularly aggressive during breeding and nesting season. Most problems occur from March through June during the nesting season. Breeding pairs begin nesting in late February and March. Egg-laying begins soon after nest construction is complete. Female giant Canada geese lay one egg every day and a half, and the average clutch size is five. Incubation of eggs begins after the last egg is laid and lasts 28 days. Geese can cause a great deal of localized damage if many young are hatched in

one area. After hatching, goslings are incapable of flight for about 70 days, so the young birds and their parents will graze near the hatching area for that time. HM Master Association and Hershey's Mill Golf Course make every effort to control the geese population. SO PLEASE DON'T FEED THE GEESE. It only exacerbates the problem.

### **Landscaping Rules Reminder to Residents**

In order to give our homeowners a consistent and cohesive appearance regarding landscaping, Village Council has eliminated "DO NOT PRUNE" lists. Those homeowners who have, over the years, added specimen plantings to supplement the landscape adjacent to their homes, need to be aware that Hershey's Mill Landscape (HML) has been directed to prune/trim all plant material throughout the community of Jefferson Village per contract specifications. Should you as a homeowner wish to prune or trim these "special plants" in advance of our pruning schedule, then HML should have no need to do additional pruning to these "special" plants on your behalf. The HML Summer Pruning Schedule will be communicated in advance, so all residents will have the opportunity to prune these "special plants" in advance of the schedule.
