### Hershey's Mill Villages, Residents, and Clubs

1. Reservation of the pool/deck for a party being held by a Village, Resident, or Club does not preclude its use by other Hershey's Mill residents during normally scheduled pool hours.
2. Reservation for a party must be made via pool email or pick up the party form at the pool sign-in desk.
3. Alcoholic beverages may be consumed in the pool area ONLY if a WAIVER OR RELEASE OF LIQUOR LIABILITY is signed by a representative of the Village, Resident, or Club. GLASS BOTTLES ARE NOT PERMITTED ON THE DECK AND MUST BE KEPT IN THE POOL COVE.
4. The pool area, kitchen, bathrooms, and locker rooms must be left clean and orderly at the conclusion of the party. All trash and recycling must be placed in their appropriate containers. MOVE TABLES ONLY WITH THE HELP OF A GUARD. A \$75 clean-up fee will be required if addition clean-up is required. See att. sheet for clean-up guidelines.

## Covenant, Release, and Indemnity

### Use of Alcoholic Beverages at Hershey's Mill Swimming Pool

\_\_\_\_\_, (the Host) desires to host one or more individuals at Hershey's Mill swimming pool at a time when alcohol beverages will be served. This shall include the pool, decks, locker rooms, and associated facilities available for use in connection with the pool. As a condition of the permissions granted to the Host to serve, or allow others to serve, alcoholic beverages at the facilities, the Host covenants and agrees as follows:

1. **The Host shall prohibit** any guest at the Pool whose faculties appear to be impaired or limited by reason of the use of alcoholic beverages from using the swimming pool; and the Host shall direct such guests to leave the Pool.
2. The Host agrees to release, indemnify and hold harmless the Hershey's Mill Homeowners Association, Wooldridge Construction of PA, Inc., their successors, assigns or affiliates, and the officers, agents, employees, and contractors of each of them, from and against any and all liability for loss of life or injury to any person, or loss of or damage to the property of any person, arising out of the use of the facilities when alcoholic beverages are being, or have been served, by Host or by any person permitted to be present at the facility by Host. As used in this paragraph, "person" shall include without limitation any firm, corporation, or association, the Host, all guests and invitees of Host, and all the parties identified in this paragraph.
3. The pool guard on duty will have absolute authority to cause any person whose faculties appear to be impaired or limited by reason of the use of alcoholic beverages to be removed from the pool area. The Host will defer to the discretion the pool guard in his or her exercise of this responsibility and cooperate fully in its implementation.
4. The Host shall cause this document to be displayed prominently at each and every location where alcoholic beverages are being served at the facility.

## Hershey's Mill Pool Party Clean-up Rules

1. DO NOT LEAVE ANY FOOD OR BEVERAGES.
2. Empty coffee grounds and clean coffee pots.
3. Wash all kitchen utensils and return them to their original places. If dishwasher is used please return the following morning to empty it and put away utensils.
4. Wipe out microwave if used.
5. Wipe off counter and tables.
6. Place trash bags in container outside back door.
7. Remove all decorative items.
8. DO NOT PUT AWAY TABLES AND CHAIRS.

**A \$75 clean-up fee will be charged if additional clean-up is required.**

The lifeguard will assist with set up, serving, and clean up. The guard is also responsible for securing and locking the pool area at the party's end.
