#### **Pool Patron Policies**

- Residents and guests must enter through main gate only, check in, and register upon arrival.
- Residents must be present and supervise their guests at all times, including locker rooms, sports area, and Cove.
- Residents must use guest passes or pay a daily admission for each guest, *even if only to sit.*
- Guests are not permitted to bring guests. No guests are to be dropped off.
- Due to capacity regulations, no more than 5 guests per household are permitted at a time. Contact Pool Manager to request an exception.
- Adult/child ratio = 1 adult per 3 children.
- Guest passes (15 punches) are \$35.1 punch per guest on weekdays, 2 punches on weekends/holidays. Guest passes are good indefinitely.
- Guest admission is \$4 on weekdays, \$6 on weekends/holidays.
- Payment by checks preferable. Make payable to "*Hershey's Mill Pool Fund*."
- Respect other bathers when using cell phones.

#### **Safety Rules**

- Not permitted: glass of any kind or pets.
- Diving from side of pool allowed only in diving area and when diving board is not in use.
- Only 1 person on diving board at any time. No running on board.
- Lap lane is for swimming laps.
- Food and beverages are permitted only in non-glass containers. Use trash containers.
- No wet suits in Cove.
- Baby pools are not permitted.

## **Health Rules**

- Shower before using the pool.
- Hair that is shoulder length or longer must be tied up.
- Immediately report all injuries or medical situations to the lifeguard on duty. Emergency 911 will be contacted as necessary.
- Anyone with draining infections of the skin, open wounds, or infectious respiratory tract disorders are not permitted in the pool.
- Don't swim for 2 weeks after an episode of diarrhea.
- No Bandaids worn in pool.
- No diapers, Pull Ups<sup>™</sup>, swim diapers, or Depends<sup>™</sup> are allowed in the pool.
- If residents need assistance into (and out of) the pool, they must be accompanied by an aide.

### **Kid-Friendly Safety Rules**

- Adults must monitor young guests (15 and under) in the Cove, bathrooms, pool, and sports facilities.
- No infants in pool. Children must be pottytrained. No diapers, Pull Ups<sup>™</sup>, or swim diapers are allowed in the pool.
- Please take children to the bathroom frequently.
- Arm floats and life vests are permitted, if adult is within arm's reach.
- Noodles and "soaker balls" are permitted.
- No kick boards. No floats. No hard toys or water guns.
- No hanging on lane lines, ladders, or the steps.
- Swimmers under 16 should not be in the lap lanes.
- Adults must be with children in walking section of the pool. Pool staff may ask you to remove children temporarily on a busy day.
- In order for the Pool Staff to know that children under 16 are able to swim safely in deep water, a Swim Assessment will be administered.
