# **Elevator Project**

Design changes have recently been made specifically to the Machine Room and Bathroom configurations. As a result, the project needs to be re-bid; however, because this is a busy time of year, it is unclear as to when a bid response is expected.

# **Chandler Road Repair Project**

Near the Village of Merrifield, Chandler road has been experiencing standing water. The problem is that in over a 500-foot area a significant slope, measuring approximately 4 feet, exists. There are bids submitted to reduce the slope from 4 feet to 2 feet; however, the bid responses are still coming in. No decisions can been made until all bids have been received and evaluated.

## Village of Kennett

The Village Council is trying to remove long-time established Village Covenant Term Limits for Council Members. If successful, the current Council will be permitted to serve until replaced via the election process. A village vote will need to be taken.

#### **Old Business**

Alarm Testing-

Marc Fraser is currntly serving on a team providing a charitable act for those less fortunate. He will not return for another week or so at which time he will strive to test the Dice boxes with the vendor. In the meantime, Dice is working on the project by establishing processes and documenting passwords. Once Marc returns, he will continue the testing process and if successful, transition could begin as early as the end of May.

#### **MA Board Position**

Boyd Mackleer mentioned that there are a couple of Board vacancies and that they are looking for candidates to fill the positions. This situation rarely occurs and therefore this is a very unique opportunity for someone to serve. The Board needs to make a decision by July, and it is important for anyone interested to contact Boyd as he is chairing the process and is the point of contact.

#### **Pool**

The Board is considering the installation of cameras at the pool. The feeling is that cameras will police the area and serve as a witness to any happenings that may occur during hours the pool is open or closed.

#### **COMMITEE REPORTS**

# **Architectural /Building Committee Report**

After a long arduous process, the Building Committee (with support from the Council) has recommended McDermott Construction as our partner to remediate Robynwood Village. We evaluated six different construction firms and ultimately chose McDermott. There were a wide variety of variables used in the selection process: price, reputation, quality of work, size of work force, ability to meet start and end dates, and a sincere demonstration of flexibility to meet the demands of all Robynwood residents to make this remediation as comfortable as possible for all residents.

We had tremendous help and input from a variety of committees including Maintenance, Finance, and Building. We are awaiting the contract from McDermott Construction and a decision from a lending institution which will help spread a portion of the costs over a longer period of time. The current trajectory puts us at a start date of a June/July time frame. Our hope is that we can begin sometime in June. If all goes well, we will be able to provide more information at a Village Meeting in early June at which time the Council will share more about

the details of the evaluation and give residents an opportunity to ask questions to experts in the business. Congratulations to all of Robynwood for finally implementing a Remediation Plan that is cost effective and complete.

## **Finance Committee**

The Finance Committee has been working closely with Council to finalize the numbers for the remediation project. A cash flow analysis was developed to make sure that a safe capital reserve fund is maintained throughout the remediation work as well as the roof replacement work over the next few years. A Robynwood Village meeting will be announced shortly to review the details of our recommendations.

# **Landscape Committee**

- 1 Mike Neale, committee, and council members did a walk around all properties on 4/18. One main issue is numerous muddy areas behind several homes. Council asked Mike to draw up a proposal, with estimate, to re-seed these areas in the fall. Some heavily-shaded areas will be difficult to get grass to grow, but we can try. Mike will complete this evaluation by mid-July.
- 2 Several dead or dying shrubs have been tagged for removal. These can be replaced at the homeowner's expense. Please contact Alex Bonnard to discuss at <a href="mailto:abonnard@hersheysmill.com">abonnard@hersheysmill.com</a>
- We were also told by Mike that all homeowners are responsible for pruning their own Hydrangeas.
- We still have over 100 trees to be pruned that were listed by John Hosbach with Rockwell several years ago. Council asked Mike to breakdown the list with costs involved and to prioritize. We hope to schedule work with Arader Tree Service as soon as possible pending approval from council.
- 5 There are several additional upgrades that were discussed with Mike such as adding decorative rocks around some mailbox posts to protect them from weed wackers and adding rocks to other areas as needed to help promote proper drainage.
