# From the Master Association

- The Master Association continues to look at drainage issues within Hershey's Mill's common areas.
- Work continues the plans to expand the Community Center. Approval has not been given at this time.

# **COMMITTEE REPORTS:**

#### **Finance Committee March 2022**

The Finance Committee met on February 18, 2022 to discuss and evaluate the following issues; 1/ The Committee wanted to make sure that all the roofing costs were accounted for in the financials as of 12/31/21. In addition, we wanted to review our final expenditures and compare them to what we had budgeted for the work.

- 2/ A review of the January 2022 financials was made to determine if all accrual type expenditures had been included for 2021. Some minor changes were discussed and forwarded to CSK for correction.
- 3/ A second review of our 2022 Budget that was approved in November 2021 was performed. Based upon the completion of our Total Project (remediation and roofing) we determined that we were under budget for our total project. This then began a discussion on other contingent issues we had anticipated IF we had the available resources. Based upon our discussion and the condition of our reserves it was decided to approve a request for TREE and Shrubbery work anticipated to cost \$50,000.
- 4/ The committee spent some time discussing our near three- year project questioning how and if the process could have been performed better. It was the consensus of the Committee that we were more than satisfied with the completion of the projects both financially and administratively.
- 5/ Finally we talked about the annual audit of Robynwood Village as of 12/31/21. We will be able to share that report upon completion sometime later in the year.

Thanks to all of our residents for their help in completing such a significant project for our community. We appreciate all that the Board has accomplished and thank them for their work.

### Maintenance/Landscape Committee

Many trees throughout Robynwood are badly in need of pruning to ensure continued healthy growth and a more attractive landscape. We have engaged AC Tree Services to prune all trees requiring attention. In addition, we are working with HMLD to identify shrubs that need to be either removed, replaced, or rejuvenated by a severe pruning. We will conduct a Maintenance walk around throughout Robynwood on April 12 to identify maintenance issues requiring attention in 2022.

# Real Estate Update for Robynwood Village and the Mill: Mariangela Hlis, Realtor, Weichert West Chester- Source Bright MLS

Currently there are 4 "Active" listings and 1 "Coming Soon" in Hershey's Mill. Prices are ranging from \$295,000 to \$520,000. There are 15 homes 'Under Contract/Pending and16 homes have settled in the last 90 days. Settled homes range from \$200,000 to \$930,000. Currently, 1275 Robynwood is pending and will settle on April 22, 2022. 1319 Robynwood is pending and will settle on May 3, 2022. Robynwood homes went under contract within 3 days. Robynwood Village has an excellent reputation and buyers are noticing. Inventory in the Mill is extremely low but increasing. It is definitely a Seller's market.
