Meeting Minutes Approval: Meeting minutes from 6/20/22 were approved and will be posted on the web.

Treasurer's report: As of 7/18/22, the HMS checkbook balance was \$17,608.57 which included the bowling balance of \$490.13.

Old Business:

- <u>Recap 6/27/22 Budget Meeting</u> with HM Finance Committee Dave and Lynn reported that the HM finance committee was amenable to the requests that originated from the leaders of the sports groups. One ancillary possibility is blacktopping the path from the Sports Complex Parking Lot to the shed between Pickleball Court 5 and the pool grounds as well as blacktopping the Sports Complex Parking Lot and relining it diagonally.
- <u>East Lawn Project Update</u> Bob reported that groundbreaking for the East Lawn Project has been moved to September.
- <u>July 4th Recap</u> Dave reported that that once again MaryAnn did a great job in organizing a holiday event. On July 4th, each person brought an appetizer or dessert to share. The tables under the pavilion were overflowing with tasty treats enjoyed by all. Water was provided compliments of Wagner Real Estate. There was no charge to those attending.
