A. Financial

Jeff Smith reported that we continue to see small overages in some line items and under spending in others which is expected. He raised a concern about landscape costs, but the major projects have been completed.

B. Landscape

Sandy LeDuc provided an updated spreadsheet of planned projects and estimated costs. She is waiting for HMLD to complete several budgeted projects.

C. Maintenance

Rod Lukens reported on the following items:

Contact was made with Richard Egan about the backlog of repairs. Egan should be back in the village after Labor Day. Rod will investigate using an additional contractor to complete repair work more expeditiously.

Rod has accepted a proposal for deck repair at 1179, with \$500 of the cost to be paid by the homeowner.

A proposal from Egan has been accepted for village directional signs.
