# VILLAGE OF ASHTON – HERSHEY'S MILL Annual Meeting

November 6, 2023

Dear Ashton Residents,

As we know, 2023 was an exciting and tumultuous year. The Phillies had us on the edge of our seats and the world was upside down. Although our concerns in our Village are minor in comparison, they are important to all of us.

We were all saddened by the loss of Kirk Leighton our long time President of Council who was a gentleman and friend to us all. We are all better for knowing him and will serve in his spirit to maintain the village as a great place to live.

#### Council year end summary:

Council: In 2023 Council continued to improve operations and procedures. Initiated best practices including structure for Council business, adherence to Roberts Rules, posting agendas and minutes on the Village website. Identified and corrected inconsistencies with bylaws and PA legal statutes, terms, and industry processes. Worked with residents to update, reestablish various activities, and sub committees in the Village,

Infrastructure: Addressed on going common area ruptures in potable water and sanitary sewer common mains. Mor Contractors were the primary site contractor to perform work. Council also coordinated and updated meeting procedures and created partnerships with vendors and Greenhill Sewer Authority to participate in sanitary sewer repairs. Created direct liaison with AQUA to address future potable water infrastructure updates.

Community Reserve Study: Completed proposal/bid process and selected Reserve Associates to complete the study. There was not a current study which was not in compliance with best practice. Council members worked with Reserve Associates staff engineers as they performed an overall site survey of faculties over many months, identified, and analyzed all the physical common components for repair and capital planning. This work will be phased in for construction over the next 5 to 10 years. Detailed construction engineering is expected to address worst case components first and carefully bid work with competitive vendors in compliance with the study!

Landscape Contract: Hershey's Mill Landscape contract expires at the end of this year (2023). The council reviewed and addressed ongoing performance deficiencies not in compliance with the contract terms. The contract was put out to bid to perform our due diligence to identify alternative vendors for comparative pricing and scope for 2024. Based on this process DiStephano Landscape Services were selected at a savings of over sixteen thousand dollars.

Landscape/Tree work: With Ashton being the first Village built in Hershey's Mill, a significant number of trees were addressed. This included removal or pruning of damaged or failing trees. The council is planning a tree replacement program to address appropriate areas for installations funded by the HOA. This includes resident initiatives approved and funded by the HOA such as the Ashton Drive entrance project and the Ashton Memorial Garden proposal.
