## • Financial Report from Linda Force:

 The Council wants to dedicate \$75,000 from the operating funds to Reserves. Council directs the monies to be placed in a 6-month or 12-month CD at the discretion of PENCO determined by the highest interest percentage - motion seconded and passed unanimously.
