

FRANKLIN VILLAGE COUNCIL MEETING NOTES June 13th, 9:00 AM, Malvern Rm., Community Center

Meeting called to order at 9:10, Malvern Room, Community Center. May 2d and 22d notes meeting notes approved by Bill, seconded by Bob.

<u>Master's Association: Margaret Callahan:</u> Margaret said here was a lot of discussion on the cell phone coverage at the Mill. Bill mentioned the coverage at his lower culde-sac is not good. Margaret also mentioned that when someone sees something to report to Security, don't wait days, but call Security right away.

<u>Financial-Jay Harter</u>: Jay mentioned there were no surprises_at the latest (May 31st) financials and by the end of the year we should be fine. Jay will be opening a 125,000 CD at 5% at The Franklin Mint soon. All board members voted their approval. Margaret Callahan our president and Jay Harter our Treasurer are authorized to sign for the cd.

Committee updates:

Architect Committee: Bob Gottschall- Bob submitted a list of items that Paul and his team would like to have a decision on (see below):

- Painting of windows- Home owner responsibility
- Security Alarms- the pad is the Village all the rest belongs to the home owners
- Light poles- all current ones Village Responsibility. Any new ones requested by home owner must be approved/unapproved by Council. Owner pays for the pole but the Village will be responsible for electric, maintenance etc.
- Railing repair-549-555Village responsible. All others homeowner.
- Home owners needing work can use their own contractor or one recommended by CSK but either need a copy of insurance coverage.
- Aluminum-framed patio enclosures- Home owner



- 550 patio repair- home owner
- 591 patio fence- can match pool
- New Architectural Guidelines- will be emailed out and posted on the web page. Jack will deliver copies to 576 and 578.
- 542 Awning request approved by committee
- 546 front door has been added to the "need to be painted" list and will be painted by the village.
- 565 window replacement finished by Pella installers- owners are pleased.

Landscape Committee: Bob Gottschall : Trimming of the village bushes was done the wk of the 9th. Michelle was not happy and has a punch list to send to HMLD.

Welcome Committee: In the future the Yellow Dot info will be the responsibility of the Welcoming Committee. Jack will supply Carolyn with 10 new packets which should be good for at least 2 years.

Pool Committee: Margaret Callahan/Bill Shipley: Pool looking good. The "solar heating" hoses seem to be working and should raise the pool temperature to a comfortable level.

<u>Communication: Bill Shipley</u> Directory up to date. Will republish the Maintenance Responsibility form when finalized
