Meeting Minutes Approval: Meeting minutes of 11/17/25 were approved.

Treasurer's Report: Lynn advised that there is \$13,594.72 in the general sports account and \$2,031.28 in the bowling account, for a total of \$15,626.00. There are no outstanding checks, and December expenses will be minimal.

Old Business:

- The Fall Sports Update was sent to all HM residents on December 1. There were over 1,500 views which is extraordinary.
- All requested information on the tennis hitting wall has been submitted to George Earle as our MA liaison. Dave will follow up after the Holidays.
- Dave updated Bob Cohen, new tennis interclub leader, on policies and procedures.
- The Committee proceeded with its review of the Bylaws.

New Business:

- The Committee welcomed Bruce Seher as the new incoming Treasurer and expressed appreciation for his willingness to serve. The Committee commended Lynn on her years of service to the Committee and for organizing the financials during her term as Treasurer. George will update the Sports Leaders list to reflect this change.
- The next Kinetics presentation will be January 20, 2026 at 2PM. The topic will be shoulders.
- As suggested by our MA Board liaison, Committee members have been assigned to serve as liaison with a specific sport(s) as follows:

- The Committee discussed whether a Sports Leader can serve on the HMSC and continue to serve as a Sports Leader. The possible conflict of interest, time commitment and the need to recuse themselves from a vote, under certain circumstances, were factors in the decision the HMSC to recommend Sports Leaders not serve as HMSC members. Final determination of the HMSC members is the HM/BOD's decision.
- Billiards will be offering clinics beginning January 7, 2026 at 7PM to include lessons and non-competitive play. Depending on response, the leaders may change the time to afternoons. They have also invited an outside group to come in and play with them. It must be stressed that any non-resident must be accompanied by a HM resident at all times.

- Platform tennis had over 20 players at their season opening event, and Marie has decorated the courts for the Holidays.
